TERM OF REFERENCE

Background & Rationale

Characterized mainly by a hot and dry climate, an arid soil, in cyclical degradation due to erosion and drought; a rare, irregular and poorly distributed rainfall, and a poor vegetation; the African Sahel region gives as a conclusion to the first observation a poor vision in terms of biological diversity unlike other regions of the continent. However, despite these biogeographical characteristics, it contains exceptional particularities and potentialities in terms of ecosystems and flora and fauna species that often have direct links and scientific affinities with ecosystems and species that are reputed to originate from the tropical forests of Africa. In terms of wildlife species, some Sahelian countries like Niger are home to species such as the Addax, the Oryx, the North African Autriches, the Dama and Dorcas Gazelle, not to mention the last herd of the Peralta Camelopardalis Giraffe, better known by its vernacular name of West African Giraffe; which are species classified by the IUCN as both vulnerable and threatened with extinction.

This is in contrast to Central Africa which is internationally recognized as the second largest tropical rainforest in the world, offering more ecosystem services; the second largest reservoir of biodiversity in the world thanks to their terrestrial ecosystems which are more favorable to the conservation and reproduction of certain animal species such as the primates (Mountain Gorillas) emblematic of the area. Also, these two regions of Sahelian and tropical Africa are both facing the same threats to the conservation of their biodiversity and ecosystems such as Population growth, uncontrolled urbanization, poaching and extreme climatic phenomena.

Based on this observation, the member countries of the United Nations established in 1992 in Rio (Brazil) the first political and legal document which is the Convention on Biological Diversity (CBD); followed by other international agreements facilitating the implementation of the CBD such as: The Cartagena Protocol on Biosafety which entered into force in 2003, the Nagoya Protocol in October 2010 and the Aichi Agreement in 2010, which is also the first strategic plan to better address biodiversity conservation challenges over a 10-year period (2011-2020). This strategic plan has expired and will be replaced by a new global framework for biodiversity post-2020, which will be formally adopted by the signatory parties of the

CBD at the Fifteenth Conference on Biological Diversity in Montreal (Canada) in December 2022 with the objective of achieving by 2050, that humanity lives in harmony with nature.

In this common struggle for the conservation of life on earth, the role of young people through their representation on the demographic level is decisive. Particularly those of Africa which is the continent where $\frac{3}{4}$ of its population is young and which moreover records the most impacts related to the loss of biodiversity and extreme climatic phenomena by our dependence on non-fossil natural resources. They are also an asset for change and the achievement of the objective of conservation and sustainable management of biodiversity as recognized by the strategic plan 2011-2020 by the Strategic Goal E. However, they know or master very little knowledge and technical information necessary on the field of conservation and management of biodiversity, especially the ways and mechanisms appropriate for the search for opportunities such as awareness training and capacity building related to the theme as an example.

This is the mission that the NGO Save The Environment Niger has given itself with the collaboration of other NGOs and Associations of French-speaking Sahelian and Tropical Africa, including the NGO MKAAJI MPYA asbl of the DRC; and the NGO EVDD of Benin. Through the creation and implementation of this project entitled International Symposium of African Youth on the Conservation of Sahelian and Tropical Biodiversity, a scientific initiative aimed at bringing together these two regions of Africa, namely the Sahel and the Tropics, for the sensitization and capacity building of young people on conservation and governance, mobilization of resources for biodiversity and especially their effective involvement.

General objective

Increase the scientific, indigenous, traditional and cultural knowledge of youth on biodiversity, ecosystem services and their conservation and sustainable management in the Sahelian and tropical regions of Africa.

Specific Objectives

 Inform and explain to youth the existing bilateral and multilateral agreements and mechanisms for biodiversity conservation in Sahelian and tropical Africa;

- To popularize and share knowledge in order to engage youth in the implementation of the Kigali Call to Action (APAC 2022);
- Develop a document of recommendations and a roadmap from the youth with the symposium for policy makers and partners in Sahelian and tropical African countries in the context of the adoption and implementation of the Post2020 Strategic Plan for Biodiversity.

Expected Results

- R1: Participants acquired the necessary knowledge on national framework agreements and laws related to some Sahelian and Central African countries; as well as those related to common policy and governance at sub-regional and international levels for biodiversity conservation and management.
- R2: The assorted recommendations of the Africa 2022 Protected Areas Congress are fully shared and explained to the youth, as well as the ways to contribute to their implementation.
- R3: The recommendations of the youth are known and recognized by political authorities and local and international partners and are subject to specific follow-up for their implementation.

Profile of beneficiaries

In accordance with the criteria defined in the Google Form for applications and the selection criteria of participants; the International Youth Symposium on Sahelian and Tropical Biodiversity Conservation, the profile par excellence are young people from African countries in the first instance, and those from other continents in the second instance. They are students, researchers, entrepreneurs, professionals, between 18 and 40 years old, interested or involved in biodiversity conservation at the local or international level.

Participant Selection Process

The phase of selection of participants will be done by a selection committee of three (3) representatives of three (3) organizations from three (3) different countries fully involved in the organization of the Symposium namely Save The Environment from Niger; MKAAJI MPYA asbl from DRC and the NGO EVDD from Benin. The process applied a strict rule of impartiality and neutrality in terms of the profiles of the participants to be selected. The only criteria on which the committee will give a particular look are: The gender of the person concerned; his or her country of residence; his or her motivation; and finally the way in which the technical and scientific achievements benefited during the symposium. The counting of the Google Form questionnaire officially put online on July 24, 2022, as well as the selection will begin a few days after August 20, 2022, closing date and end of receipt of applications. In total, a number of 150 young people, among whom Seventy-five (75) women will be selected and notified through an email for the confirmation of their selections. Particular attention will be given to the application of young people from the direct target countries for the Symposium listed above.

Sahelian Africa

This is the African countries of the Sahel region, a transition zone separating the Sudanian savannah in the south from the Saharan desert in the north. The area is located in the northern part of Africa which extends from the Red Sea to the Atlantic Ocean with an area of 1, 178 850 km2. The countries directly concerned by the International Youth Symposium on the Conservation of Sahelian and Tropical Biodiversity are the six (6) core countries of the Sahel, including: Senegal, Mauritania, Mali, Niger, Burkina Faso and Chad all marked by an arid and semi-arid climate and by the desert and by a relatively modest biodiversity in terms of capacity.

Tropical Africa



It is the Central African countries that are home to the second largest tropical rainforest in the world. This major reservoir of biodiversity extends mainly over five countries: Cameroon, Gabon, the Republic of Congo, the Democratic Republic of Congo, and the Central African Republic.

Implementation of the Symposium

The Symposium will be implemented in October 2022, i.e. one month before the COP 27 on Climate Change and two (2) months before the COP 15 on Biological Diversity. It will be carried out entirely in virtual format (On-line); however, the stakeholder organizations in the organization are strongly encouraged to hold a restitution or capitalization workshop in their country according to their financial means. The tentative date is October 20-21, 2022, on the ZOOM US application, whose link and access code will be available soon. However, these dates are subject to change depending on potential technical constraints.

The holding of this online symposium is explained by the organizers' desire to give a large number of young people across Africa the opportunity to attend without too many constraints or difficulties and to build their capacity on the theme.
